On 7/30/2024 the Court granted Plaintiff's Motion for Order Permitting Plaintiff to file a Second Amended Complaint. The Court's order stated:

"Plaintiff's motion to file a Second Amended Complaint is granted. Plaintiffs is ordered to file the Second Amended Complaint within 14 days of this order." Consequently, Plaintiff was ordered to file his Second Amended Complaint no later than 7/13/2024. As of 9/24/2024 Plaintiff has failed to file a Second Amended Complaint.
